

LINN COUNTY BOARD OF SUPERVISORS
CEDAR RAPIDS, LINN COUNTY, IOWA
MONDAY, AUGUST 17, 2020 11:00 A.M.

The Board met in session at the Linn County Jean Oxley Public Service Center. Present: Chairperson Rogers, Vice Chairperson Oleson and Supervisor Walker (via phone). Board members voting "AYE" unless otherwise noted.

Chairperson Rogers called the meeting to order.

Motion by Rogers, seconded by Walker to approve minutes of August 10, 11, 12, 13 & 15, 2020 as printed.

The Board discussed actions related to county damages from the storm of August 10, 2020 as follows:

- President Trump signed a Federal Disaster Declaration.
- Fillmore Building is getting a generator today.
- Risk Manager is measuring capacity of Ceres trucks for hauling rural resident debris (per FEMA).
- Morgan Creek & portion of Dows Farm to be first rural sites for rural resident organic debris.
- Solid Waste Agency is not waiving tipping fees for storm debris.
- EOC calls will occur daily at 9 a.m. and 4 p.m.
- Supervisor Walker and interns are at the Harris Building for food distribution.
- Uncontrolled burns are a concern of the Sheriff's Office.
- Group hauling areas for burning is a concern and not allowed.
- County Home Rd. water tower is back on line.
- Encourage county departments to move forward with planned budgeted projects.

The Board deferred the review of the draft Governing Plan for Dows Farm Agri-Community until Wednesday.
